Fentanyl Awareness Resources - Curated for Schools

This list includes some available resources that schools can access now to educate faculty, parents and youth for substance abuse prevention and intervention, including awareness of the dangers of fentanyl. While not an exclusive list of resources, this is a good place to start with your planning efforts.

Texas Health and Human Services Commission (HHSC)

- Speakers/Presentations/Referral Information: HHSC funds Prevention Resource Centers (PRC) throughout the State of Texas. PRCs facilitate substance use/misuse prevention curriculum for youth and provide workshops for parents. Some PRCs provide fentanyl awareness presentations for schools when requested. Each center is unique. PRCs can link families with youth treatment and recovery resources. Contact your regional PRC for additional information and to request support.

- Other Connections to Treatment: Another place to connect families with support and services is your regional Outreach, Screening, Assessment, and Referral (OSAR) resource. The OSARs are funded by HHSC to help Texans confidentially address substance use/misuse and addiction. - Drug Disposal Resources for School Nurses and The Community from the University of Houston College of Pharmacy
 - Approximately 50% of children under the age of 18 who misuse prescription pain medications obtain them from friends or family members (<u>National Survey for Drug Use</u> and Health, 2013).
 - Access to safe drug disposal resources removes unused medications from the home and prevents misuse and unintentional harm.

- The Prescription Drug Misuse Education and Research (PREMIER) Center at the University of Houston College of Pharmacy is working with HHSC, school districts and community groups across Texas to provide at-home drug disposal resources to help school nurses remove unused drugs from their clinics and families to dispose of unused medication in the home.
- Families in your district can pick up DEA approved, take-home, mail back drug disposal envelopes from the locations on this map to help clean out their medicine cabinets or remove substances from the home.
- In the next week, the PREMIER Center will be reaching out directly to superintendents statewide with information on how they can obtain drug disposal envelopes to help nurses in their schools and members of the community dispose of unused or unwanted medication as part of local prevention efforts.
